#### Please Read and Sign

- 1. <u>Non-discrimination Policy</u>: As a registered organization or business, we agree not to use The Tapestry Time Bank members for activities or programs that discriminate according to gender, sexual orientation, socio-economic status, ability, race, age, political or religious affiliation. Organizations and businesses whose policies, procedures or practices include discrimination against any of the previously listed groups, or organized political parties are not eligible for membership in the Tapestry.
- <u>Conviction Statement</u>: In accordance with the board, criminal and abuse checks will be attained by the Time Bank staff on all participating individuals. All individuals will fill out a disclosure statement and checks will be performed. I understand that a conviction will not automatically disqualify any individual from volunteer service, but may affect the degree of participation which can be reasonably allowed in accordance with the risk management policy.
- 3. <u>Nature andLimitations</u>: Our organization/business agrees not to eliminate paid positions for the specific pupose of making positions available for Time Bank members. We will adhere to the debit/credit ratio proposed by The Tapestry and seek guidance in formulating options for earning or spending, as the case may be.
- 4. <u>Liability Insurance</u>: We understand that volunteers are afforded liability insurance while acting in good faith. Intentional misconduct or knowing violation of the law will result in nullification and subsequent civil action could occur. We are aware that all members must have a valid driver's license and personal auto insurance in order to participate in job duties that involves transporting people and/or products for The Tapestry Time Bank.
- 5. <u>Fee Structure</u>: We agree to pay an annual fee for participation in The Tapestry and understand that no nonprofit organization will be turned away due to inability to pay. (See suggested fee scale for reference.)

#### **Volunteers**

Although membership dues are an important part of the Time Bank's budget, no organization will be denied membership because of inability to pay. Any organization may apply to The Tapestry Board of Directors to request a dues waiver. Waivers will be considered for the first six month of membership. We will work with your organization to find creative ways to maintain membership after the six month waiver period.

## **Suggested Dues Structure for Organizational Membership**

Your Organization's Annual Budget	Annual Dues
\$100,000 or less	\$50
\$250,000 or less	\$100
\$500,000 or less	\$250
\$1,000,000 or less	\$500
\$1,000,000 or more	\$750
